How did we obtain your personal data?

SJRM has obtained your data because you have provided this data to us, and because SJRM has obtained your information from third parties. These third parties are: Fans, bookingskantoor, platenlabels, promoters, festivals, reisbureau, marketeers.

What are your rights?

Under the European General Data Protection Regulation you have a number of rights with regard to your data and the processing thereof:

Access

You may access your personal information and make any necessary changes in your account. If you would like to see which personal data SJRM has obtained about you, you may exercise your right of access by submitting a request to SJRM.

Making changes

If you wish to make changes to the personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that SJRM makes these changes for you. You may request that SJRM modifies, corrects, supplements, erases or shields your information.

Restriction of processing of personal data

You also have the right, under certain conditions, to ask SJRM to restrict the processing of your personal data.

Right to object

If processing of your data takes place on the grounds of 'legitimate interest' by SJRM or a third party, you have the right to object to that processing.

Portability of data

You have the right to obtain your personal data from SJRM. SJRM will provide this in a structured and commonly used format, which can easily be opened using commonly used digital systems.

Withdrawing consent

When the legal basis for a particular processing is your explicit consent, you have the right to withdraw that consent. This does not affect past processing, but does mean that we will no longer be allowed to process this data in the future. It may also result in SJRM no longer being able to provide you with certain services.

Response from SJRM

A request can be sent to <u>info@sj-rm.com</u>. SJRM will comply with your request as soon as possible and in any case no later than one (1) month after SJRM has received such a request. If SJRM rejects your request, we will indicate in our reply why the request was rejected.

Recipients of your personal data

Your data may be transmitted to:

- Data processors
- Parties that are involved in the execution or fulfilment of an agreement between you and SJRM
- External consultants

It is possible that SJRM is required to submit your data to a third party, for example to fulfil a legal obligation.

Transfer to third countries or international organisations

It may be necessary, for instance for technical and operational reasons, to transfer your (personal) data to affiliates of SJRM located outside the European Economic Area. Due to the possibility that the regulations in the area of privacy protection do not offer the same protection as within the European Economic Area, SJRM will use the Privacy Shield or the EU Model Clauses to protect your privacy as much as possible. If that is not possible, SJRM will ask your consent to transfer your (personal) data to countries that do not maintain an adequate protection level. You may withdraw your consent at any time.

What are cookies and how does SJRM use them?

Cookies are small pieces of (text) information that are sent to your browser when you visit the website of SJRM and then stored on the hard disk or in the memory of your device. The cookies placed via SJRM's website cannot damage your device or the files stored on it. With 'cookies', we also mean comparable techniques collecting information, such as device fingerprinting.
